The Commissioners Court is looking for proposals for Mosquito Control's aerial spraying. Proposals addressed to the Commissioners Court of Chambers County will be received at the office of the County Judge until 2pm, Thursday, June 3, 2010 for the following services:

**Contractual Pilot/Mechanic Services**

Job will consist of dispensing chemicals Malathion and Naled at altitudes of 150 to 200 feet at pre-dawn and post-dusk hours in Chambers County residential and rural areas for the assistance in the abatement of mosquitoes.

For the contractual pilot service proposal, the pilot must have a F.A.A. Commercial Pilot certificate; minimum 1000 total log hours and minimum 100 hours in Cessna 188B aircraft.

4. Proposals shall be sealed and forwarded to County Judge Jimmy Sylvia, Chambers County Courthouse, PO BOX 939, 404 Washington Ave., Anahuac, TX 77514. The County shall reserve the right to waive bid informalities, to reject any or all bids, and to make the award as may be most beneficial to the County.
5. Any variation from these specifications must be indicated on the bid or on a separate attachment to the bid and shall be labeled as such.
6. Prices quoted shall be for one year from date of award.
