#### Message from the President



Mike Nichols

I started my last message with a Chinese proverb, so in keeping with that theme, let me share this: "Even a mosquito doesn't get a slap on the back until it starts to work.".....Austin O'Malley. By now many of our members' programs are in full swing, with surveillance programs running continually and control methods being employed as necessary. Most members are fortunate in that in many areas of Texas the control efforts needed have been minimal thus far. Texas is well ahead of average this year regarding rainfall, with only parts of deep south Texas being a little dry, but those widespread rains have only caused hatches of nuisance mosquitoes in limited areas. Similarly, state wide viral activity in 2019 is well behind the levels seen at this point in time in both 2017 and 2018. As of June 25, TDSHS has reported only 46 mosquito pools positive for WNV over 5 counties. We certainly shouldn't let our guard down, but if this trend continues it could be a year with light activity.

In May I was able to attend my first AMCA Washington Day, and it was quite a unique experience for me. Joining me from Texas this year were Nina Dacko, Vector Control Supervisor for Tarrant County, Dr. Umair Shah, Executive Director of Harris County Public Health, Dr. Mustapha Dubboun, Director of Mosquito Control for Harris County Public Health, Albert Cheng, Manager of Government Affairs for Harris County Public Health, and Ed Bredemeyer, Director of Sales West for Central Life Sciences. With 6 people in attendance from Texas, I believe we set a record for our organization, and I would like to thank each of these attendees for their time and effort in representing our state, our organization, and our industry. The trip consisted of two days, one spent in conference learning about the issues affecting our industry, and one spent on Capital Hill visiting with legislative aids about these issues. Having never attended this trip previously, it provided a unique insight into the workings of our federal government. Though at times as individual US citizens we feel small and as though we have very little say in laws and regulations, I am still proud to live in a country where we have an open government where through political and public policy processes we are provided with opportunities for civic engagement with our Congressmen and Senators. I highly encourage any and all TMCA members with the ability to travel for meetings such as this to attend in the future.

This year the TMCA Annual Meeting will be held October 9<sup>th</sup>-10<sup>th</sup> at the Hilton Garden Inn in Waco, TX. Details on this meeting can be found within this newsletter. Though there proved to be a few snags in finalizing a location, we are fortunate enough again to be able to announce the location fairly early in the season so as to allow our members ample time to get approval for travel. A big "thank you" to Dr. Durhkopf for his hard work in making arrangements for this meeting. Also, we were fortunate this year in being able to secure Joe Conlon as our Adapco keynote speaker. For those of you who have not listened to or spoken with Joe, you have been missing out on a great resource. Joe has been the Technical Advisor for AMCA for many years now, and is a wealth of knowledge. I look forward to his presentation this fall.

Another thing that happens at our Annual Meeting is the election of new board members. As most of you are aware, we approved a new board structure in 2017, and then implemented it in 2018. As part of that new structure, we now elect two additional board members annually, one to a 2-year term and one to a 6-year term. If anyone is interested in serving as a board member for the Association, please reach out to our nominating committee and discuss this opportunity.

Finally, something else exciting will also be happening soon....we will have a new website. Megan McNairn has been working with Dr. Duhrkopf on making the necessary monetary arrangements for the new site, and she is almost ready to transfer the domain and go live. It will be a glorious day when that finally happens.



#### Texas Mosquito Control Association Legislative Committee Report June 28, 2019

- I. The Pandemic and All-Hazards Preparedness and Advancing Innovation Act (PAHPIA) (S. 1379), which includes the Strengthening Mosquito Abatement for Safety and Health (SMASH) Act, was signed into law on June 24<sup>th</sup>. This bill provides funding to political subdivisions in response to a public health threat from mosquito and vector transmitted diseases. This bill only authorized the funding, but those funds must still be appropriated.
- II. AMCA and member organizations have begun contacting congress requesting \$300,000 in funding for the Department of Agriculture's IR-4 Public Health Pesticides Program (PHP) within the FY 2020 Agriculture Appropriations bill.
- III. Issues surrounding the Endangered Species Act (ESA) continue to plague our industry and our efforts to protect public health. AMCA recently composed a letter to the secretary of the interior regarding a petition to protect the Gulf Coast Solitary Bee, correcting inaccuracies about mosquito control included in the petition. Also, the EPA recently presented a draft revised method for conducting national level threatened and endangered species biological evaluations for pesticides.

#### Distribution of *Culex coronator* in Texas

For those who have been following this study, the data collection was completed in the fall of 2018 and in April 2019, the article was published in the *Journal of the American Mosquito Control Association* (JAMCA). The study presented data supporting the presence of *Culex coronator* in 127 Texas counties. #### Mosquito Species Checklist for Thirteen (13) Counties West of San Antonio

Retired Army Entomologists, Bill Sames and Ray Dunton, are compiling a mosquito species checklist for 13 counties (Bandera, Edwards, Kendall, Kerr, Kimble, Kinney, Maverick, Medina, Real, Sutton, Uvalde, Val Verde, and Zavala) west of San Antonio based upon published (science journals) and unpublished (county surveillance data, government and military reports, university and private collections) records, then confirming those data with primarily larval collections in each county. This is their third year of collecting specimens and this fall, they hope to bring this study to a conclusion with potential publication in the spring of 2020. Preliminary data suggest there will be 30-35 species per county. #### **Eligibility:**

In order to be considered eligible to enter the competition, each participant must be:

#### Abstract:

An abstract must be submitted to enter the competition. The abstract deadline is **August 31**, **2019**. Each abstract should be approximately 100 words long and summarize the main objective, methods, results, and conclusion of the presentation. The abstracts will be judged on grammar, organization, and content. Participants will be notified regarding acceptance in **September, 2019**. #### Presentation:

Each presentation, including those with multiple speakers, will be allotted **12 minutes**. This includes time for questions so the presentation itself should not exceed **10 minutes**. (The time slot assigned for each presentation is subject to change due to last minute program changes.)

#### Judges:

The TMCA YP Committee will select three judges to score the presentations. The judges will not be members of the TMCA YPs.

#### **Evaluation:**

The competition will occur during the 2019 Annual TMCA Meeting. The presentations will primarily be judged on organization, delivery, and visual design. The evaluation system for this competition is subjective ranking by the three judges.

#### Awards:

One presentation will be selected for first prize. One runner-up and two honorable mentions may be awarded at the judges' discretion. If a presentation given by a group is awarded a prize, the entire group will share the award.

# **Texas Mosquito Control Association Membership Application**

**Purpose:** To assist in promoting public health and comfort through the control of disease transmitting and pestiferous mosquitoes, to provide for the scientific advancement of Association members, and to stimulate public interest in mosquito control activities.

**Publications:** A Newsletter is published quarterly and emailed to active members. The Association web site is located at **http://www.texasmosquito.org** 

**TMCA Annual Fall Meeting:** Held each year during October at an announced site within the state. Papers presented at this meeting are primarily technical reports dealing with new and improved methods of mosquito control, new insecticides and application techniques. Basic research related to mosquito life cycles, bionomics, diseases, and natural histories are also presented. Distributors are present to display and answer questions about their equipment and chemicals. A registration fee is required to attend.

**TMCA Spring Workshop:** Held each year during February or March at an announced site within the state. This is a basic training workshop on the operational aspects of mosquito control. Topics include general mosquito biology, mosquito borne diseases, sampling and surveillance techniques, methods of mosquito control, public relations, equipment maintenance, chemicals and chemical safety, record keeping, administrative problems, and advanced operational training in calibration, droplet size determination, mosquito identification, and surveillance devices and techniques. Distributors are present to display and demonstrate their products. Registration is free, and several meals are usually provided by the TMCA to help reduce costs to attendees.

**CEU's:** CEU's for the Texas Department of Health Vector Control Certified Applicator License are offered at the Spring Workshop. Fees are \$20 per hour of CEU requested for non-members, free to all TMCA members. **Annual Dues:** Dues are payable on a calendar year basis. Active Memberships are \$30 per year, and Supporting Memberships are \$60 per year.
